


STEWARD TIPS

44 Ways to Expand the Financial Base of Your Congregation

In his book, "44 Ways to Expand the Financial Base of Your Congregation", Lyle Schaller observes the "combination of sharply increased incomes, vast increases in accumulated private wealth, and longer life expectancy has created a new generation of relatively affluent mature adults." Schaller contends that these changes raise three policy questions on church finances:

- 1) Do you want to encourage people to remember your church in their will?
 - What percentage of your current church membership have remembered the congregation in their will?
 - What new ministries could be started if people remembered the congregation in their will?
- 2) Do you want to encourage substantial memorial gifts?
 - What policies does your congregation have regarding the use and designation of memorial gifts?
 - How does your congregation encourage people to give generously to memorial gifts?
- 3) Do you want to create a separate trust or foundation, with its own officers and reporting system, that will have the full jurisdiction over bequests and memorial gifts?
 - Does your congregation have an endowment or trust fund? If so, how is it administered?
 - How would an endowment or trust fund encourage a more generous response to mission giving by congregational members?

- 7 Principles for Growing Stewards includes a description of seven biblical principles based on II
 Corinthians 8:1-5. Principles include: Gratitude; Generosity; Abundant Joy; Give Freely; Sacrifice; Share;
 and Commitment.
- Glossary of Stewardship provides definitions of commonly used stewardship terms, for example:

First-Mile Giving:

This is financial giving to the ongoing ministry of the congregation including worship, education, evangelism, social ministry, facility operating costs, and administration.

Second-Mile Giving:

This is financial giving to support ministries inside and outside the church that are important to the giver, and beyond the ongoing ministry of the congregation. The portion of offerings that congregations share with their synod and churchwide ministries for God's work both in and beyond the congregation.

Mission Support:

Based on New Testament teaching, this involves returning a portion of one's

gifts to God in accordance with how one has been blessed by God.
