Be the Bridge, Excerpt read: Understanding Begins with the Right Posture. Questions for Reflection and discussion followed:

- 1. What captures your attention?
- 2. What questions do you have? What do you wonder?
- 3. Do you approach conversations of racial reconciliation as if you have all the answers? Do you approach those conversations with a willingness to be corrected? What do you think it looks like for participants to approach those conversations in humility?
- 4. Where might God's Spirit be nudging us?

A very rich discussion ensued followed by A Prayer for Humility from Latasha Morrison:

Lord, we ask that (these) words ... fall on the soil of our hearts.

Come into our brokenness and our lives with your love that heals all.

Consume our pride and replace it with humility and vulnerability.

allow us to make space for your correction and redemption.

Allow us to bow down with humble hearts, hearts of repentance.

Bind us together in true unity and restoration.

May we hear your voice within the words ... (spoken and shared).

Give us collective eyes to see our role

in repairing what has been broken.

Allow these words to be a conduit for personal transformation

that would lead to collective reproduction.

B. Discussion of bishop election process as a synod call process

It was noted that Churchwide chairs the Bishop election process. An ELCA toolkit will be available soon. While it is recommended to create an election committee to decide questions and create protocols there is no provision on how to move forward. The synod deans request time at the 2023 Synod Assembly on Thursday for consideration for what the C/SIS is called to be, for a Friday morning question/answer session with the candidates and in breakouts on Friday afternoon. Deans continue to be in conversation about how to create this as a prayerful, Spirit-led

process. It was noted that perhaps some work could be done in Spring Conferences ahead of the assembly. Bishop Roth also noted that because a first vote will be taken in March, some time on the assembly agenda could be applied to a different approach to discerning the election.
